## I CALL TO ORDER

Supervisor Seneck called the regular meeting to order at 7:00 p.m.

# II PLEDGE OF ALLEGIANCE

## **III APPROVAL OF MINUTES**

# IV NBT BANK INVESTMENT PRESENTATION – MARK PRIAN

Mark Prian, Sr. VP Institutional Wealth Management Consultant with NBT, discussed an Investment Management Account for Treasury Bills. Interest is high for the short term (ex: next 12-18 months). Treasury bills may be purchased in tiers (3, 6, 9 or 12 months) to aid with our cash flow needs. It is a very customizable plan. We would buy on the open market and purchase at a discounted rate. Treasury bills are backed in full faith and credit by the US government. There is no benefit to invest beyond a 12-month period. The current yield on a 12-month investment is maxed at 5%. A 3-month investment yield is near 4.9%. After a nominal fee from NBT the yield would be approximately 4.7%.

Our Board would need to establish the investment management account utilizing the Treasury bill approach and who controls it, designate who has the authority to open and close the account, and who can authorize the investments.

RESOLUTION – Motion to establish the Investment Management Account at NBT Bank and authorize the Chief Fiscal Officer/Town Supervisor, and Deputy Supervisor to be authorized controlling individuals of the account, moved by Councilmember Terry Ives. Seconded by Councilmember Gilda Ward.

- 1. **HIGHWAY COMMITTEE** Councilmember Retz reported the following:
  - a. Highway truck #22 is back in service.
  - b. Dodge 1-ton truck has not been delivered and get no response from the vendor.
  - c. Build date and pricing on a highway truck is expected in June.
  - d. Chipper was repaired in house.
  - e. Fuller Gravel will crush millings, and these will be used on Ken Stead Road this spring.
  - f. Roadside mowing is in progress.
  - g. Docks are almost complete.
  - h. Box dump locks are in for the highway trucks.
  - i. Plowed twice on Saturday, 3/4/23, as it was a very wet, heavy, and messy snow.
  - j. Grant funds are possible to pay for culvert replacements.
- 2. **BUILDING COMMITTEE** Councilmember Ward reported the following:
  - a. Met to discuss the cold storage building. There are two ideas for the design. The location of the current septic system at the highway garage is a concern.
  - b. Outside stairs need replacing, possibly with concrete and safety treads.
  - c. Vandalism continues at the Mt Upton park.
  - d. Insurance money has come in for the garage door damage.
  - e. The raised sidewalk by the Town Hall can be painted to indicate the hazard. Sidewalk repairs will be scheduled for this Spring and will include drainage.
  - f. A State inspector was in looking at the boilers at the Town Hall and the Highway Garage. We are required to have an inspection completed by our insurance company and the Town Hall boiler needs work on the relief valve.
- 3. **PLANNING COMMITTEE** Chairperson Bob Davis reviewed a simple subdivision request for Carl and Elsie Johnson (Eric Johnson) on County Road 36, tax map #197.-1-16.

Taxpayers can take the exemption or the tax credit but not both. Nothing will happen this year as it has passed the March 1 deadline. This is a residential savings only and would require work by the assessor. No action taken.

DISCUSSION - revisions have been made to the law at the suggestion of Councilmember Gilda Ward. Enforcement is the issue and the town will need to hire a Code Enforcement Officer. Steve Fox would be interested in the position. He is willing to come to the next Town meeting.
