### Section 1: Maintainance of sidewalks:

Every legal and equitable owner, occupant and lessee of land in the Town of Guilford shall keep sidewalks abutting such lands free from obstructions, snow, ice or icy conditions and shall at all times keep such sidewalks in good and safe repair and maintain the same, clean, free from filth, dirt and weeds. No person, such owner, occupant or lessee shall place or keep or suffer to replace or kept on such sidewalks any merchandise, display signs or other material things or in any manner obstruct or interfer with the use of any such sidewalk. Nothing herein contained shall prevent the temporary placing of merchandise or household furniture on the sidewalk while loading or unloading the same providing it be done without unecessary delay.

# Section 2: Notice of Failure to Maintain Sidewalks:

Written notice of a violation or violations of section 1 of this local law shall be served by the town superintendent of highways or the town clerk on the occupant, legal or equitable owner, or other adult person on the premises abutting the sidewalk on which the violation or violations exist, describing the violation or violations and requiring removal of the conditions constituting the violation within 24 hours after service of said notice. In the event such premises are untenanted or vacant, or if tenanted or occupied, the tenant, occupant, legal or equitable owner or other adult person can with do diligence be found on the premises, or in an event notice of violation or violations is served and the violation is not remedied within 24 hours after service of said notice, the town superintendent of highways is hereby authorized and directed to cause the same to be done at the expense of the town, and any and all such expenses to be audited and paid by the town.

#### Section 3: Reimbursement for town maintenance:

The town shall be reimbursed for the complete cost for the removal of conditions constituting a violation or violations of this local law pursuant to and in accordance with the manner provided in section 4 of this local law.

#### Section 4: Manner of Reimbursing town:

If the town superintendent of highways remove a condition or conditions constituting a violation or violations of this local law the town clerk additional space is needed, please attach sheets of the same size as this and number each)

shall send an itemized bill for the same too the legal owner of the premises abutting the sidewalk or sidewalks and also to any adult person occupying the said premises. The bill shall be paid to the town of Guilford within 30 days after the date on the bill. If the bill is not paid within the said 30 day period, the unpaid bill shall become a charge upon the premises abutting said sidewalk or sidewalks and the town clerk shall notify the chairman of the town board of assessors and the Chenango County Tax Department to levy the amount of said bill upon such premises and collect the same as a part of the next real estate tax statement or bill for said premises.

# Section 5: Separability Clause:

If any clause, sentence, paragraph, section or part of this local law shall be adjudged by any court of competent jurisdication to be invalid, such judgment shall not effect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in a controversy in which such judgment shall have been rendered.

### Section 6: Effective Date

This local law shall be effective upon its adoption and filing with the secretary of state.
