- SECTION 1. SHORT TITLE. This local law shall be known and may be cited as the local law prohibiting the possession and consumption of alcoholic beverages in public places in the Town of Guilford.
- SECTION 2. POSSESSION PROHIBITED. No person shall have in his possession or carry or transport any open bottles or open containers containing liquor, wine, beer or other alcoholic beverages while such person is in or upon the public park located in the center of the Hamlet of Guilford or in or upon the swimming area on Guilford Lake that is leased by the Guilford Town Board for public use.
- SECTION 3. CONSUMPTION PROHIBITED. No person shall drink or otherwise consume liquor, wine, beer or other alcoholic beverages while such person is in or upon the public park located in the center of the Hamlet of Guilford or in or upon the swimming area on Guilford Lake that is leased by the Guilford Town Board for public use.
- SECTION 4. TOWN BOARD PERMIT. Any firm, association, group or organization desiring exemption from the provisions of this local law shall file a request in writing with the Town Clerk. The written request shall contain the following information: name, address and telephone number of the applicant; date or dates the exemption is applied for; nature of the function to be held and specify the exact location for the possession and/or consumption of alcoholic beverages. The Town Clerk shall transmit the request to the next Town Board meeting. The Town Board at the meeting at which the request is presented shall grant or deny the request. The Town Clerk within three (3) days after Town Board action on the request shall notify the applicant by regular mail of the Town Board's action on the request.

SECTION 5. PENALTY FOR VIOLATION. Any person in violation of this local law shall be subject to a fine not greater than Fifty Dollars (\$50.00).

SECTION 6. EFFECTIVE DATE. This local law shall be effective upon filing with the Secretary of State of the State of New York and pursuant to the provisions of the Municipal Home Rule Law of the State of New York.
