SECTION 1. TITLE

This law shall be known as the Winter Parking on Town Roads Law.

SECTION 2. DECLARATION OF PURPOSE

It shall be unlawful to park any motor vehicle on the shoulder of any Town Road in the Town of Guilford between the hours of 6:00 p.m. to 6:00 a.m. from December 1st to April 1st or for a continuous period of more than twelve hours between the months of December 1st and April 1st.

The purpose of this law is to facilitate snow removal from the Town Roads.

SECTION 3. VIOLATIONS AND PENALTIES

A violation of this local law shall be punishable by having the violator's vehicle towed and the violator shall be responsible for the towing charge. In addition, a violation of this local law shall be punishable by a fine not to exceed \$100.




