

LOCAL LAW NO. 1 OF THE YEAR 2020

A LOCAL LAW ESTABLISHING A DATE FOR THE MEETING OF THE BOARD OF ASSESSMENT REVIEW OF THE TOWN OF GUILFORD

Be it enacted by the Town Board of the Town of Guilford as follows:

Section 1: Legislative Intent.

To establish a date other than the fourth Tuesday of May for the meeting of the Board of Assessment Review to hear complaints in relation to assessments, pursuant to the authority conferred on the Town Board by Section 512 (1-a) of the New York Real Property Tax Law.

Section 2: Grievance Day.

Commencing with calendar year 2020, the first Friday after the fourth Tuesday of May of each year is established as the date upon which the Board of Assessment Review shall hear any complaints in relation to assessments.

Section 3. Remainder.

Except as hereinabove amended, the remainder of the Code of the Town of Guilford shall remain in full force and effect.

Section 4: Severability Clause.

The provisions of this Local Law are separable and if any provision, clause, sentence, subsection, word or part thereof is held illegal, invalid, unconstitutional, or inapplicable to any person or circumstance, such illegality, invalidity or unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, subsections, words, or parts of this local law or their application to other persons or circumstances. It is hereby declared to be the legislative intent that this local law would have been adopted if such illegal, invalid, or unconstitutional provision, clause, sentence, subsection, word or part had not been included therein, and as if such person or circumstance, to which the local law or part thereof is held inapplicable

Section 5: Effective Date.

This Local Law shall be effective immediately upon filing with the Secretary of State, pursuant to Section 27 of the Municipal Home Rule Law.
