SECTION 1. PURPOSE. The Town Board of the Town of Guilford finds that certain uncontrolled behavior of dogs occasionally causes nuisances within the Town. The purpose of this local law is to protect the health, safety and well-being of residents of the Town by imposing restrictions on those who keep or harbor such dogs.
SECTION 2. SHORT TITLE. The title of this local law shall be "Dog Control Law of the Town of Guilford".
SECTION 3. DEFINITIONS. [a] "Dog" shall mean female or male, licensed or unlicensed.
[b] "Owner" shall mean any person who owns or harbors a dog.
[c] "Harboring a dog" shall mean having a dog in ones custody or

[d] "Town" shall mean and designate the area within the limits of the Town of Guilford.

charging a violation of this local law.

- SECTION 4. RESTRICTIONS. It shall be unlawful for any owner of any dog in the Town of Guilford to permit or allow such dog to:
- [a] Engage in habitual loud howling, barking, crying or whining or conduct itself in such a manner as to unreasonably disturb the comfort or repose of any person other than the owner of the dog.
- [b] Uproot, dig or otherwise damage any vegetables, lawns, flowers, garden beds, or cause any waste or damage to property not belonging to the owner of the dog.

- [c] When off the property of the owner or harborer shall chase, jump upon or at or otherwise harass any person in such a manner as to reasonably cause intimidation or fear or to put such person in reasonable apprehension of bodily harm or injury.
- [d] When off the property of the owner or harborer shall bite or cause physical harm to any person.

SECTION 5. COMPLAINT.

- [a] Any person who observes a dog in violation of this law may file a complaint under oath with the Town Justice, or his lawful substitute as provided by law, specifying the nature of the violation, the date thereof, a description of the dog and the name and residence, if known, of the owner or harborer of the dog.
- [b] Upon receipt by the Town Justice of any such complaint, he shall summons the alleged owner to appear in person before him for a hearing, at which both the complainant and owner or harborer shall have an opportunity to be represented by counsel and to present evidence. If, after such hearing, the Town Justice decides that further action is warranted, he may order:
- [1] The owner or harborer to restrain such dog by collar and leash at all times whether on or off the owner's property.
 - [2] The owner to confine such dog to the premises of the owner.
- [3] Such other remedy authorized by law as may be warranted by the circumstances of the case.
- [c] A violation of any order issued by a Town Justice under the provisions of this section shall be an offense punishable, upon conviction thereof, as provided in Section 6 of this local law.
- SECTION 6. PENALTIES. Upon conviction, a violation of this local law shall be deemed an offense and punishable by a fine not exceeding Twenty-Five Dollars (\$25.00) for the first offense and Fifty Dollars (\$50.00) for each offense thereafter.
- SECTION 7. SEPARABILITY. Each separate provision of this local law shall be deemed independent of all other provisions hereof, and if any provision hereof shall be deemed or declared invalid, all other provisions hereof shall nevertheless remain valid and enforceable.
- SECTION 8. REPEALER. This local law shall supersede all prior local laws, ordinances, rules and regulations relative to the control of dogs within the Town of Guilford, and they shall be, upon the effective date of this local law, null, void and of no further effect.
- SECTION 9. EFFECTIVE DATE. This local law shall take effect immediately upon its filing in the Office of the Secretary of State in accordance with the provisions of Section 27 of the Municipal Home Rule Law.
