Section 1. SHORT TITLE. Curfew Law of the Town of Guilford.

Section 2. HOURS EFFECTIVE. No persons shall be upon the public streets of the Hamlet of Mt. Upton, Chenango County, New York, within the lighting district of said Hamlet of Mt. Upton after 9:00 p.m. on October 31 (Halloween) until 5:00 a.m. on November 1, other than for purposes of Carrying on a legitimate business or for emergency personal purposes.

Section 3. VIOLATIONS AND PENALTIES. Any person who violates the provisions of this local law shall be subject to a punishment by a fine not to exceed Fifty Dollars (\$50.00) for each separate offense and each violation thereof shall constitute a separate offense.




